Committee Reports:

Social events

- a. Susan Wooden withdrew from the social committee.
- b. Margaret and Barbara will attempt to find a replacement for Susan.
- c. Next Event; PPOA Thanksgiving Party will be held at the Korf's. Sharyn will purchase plastic wine glasses. Margaret will inventory the supplies and email the Korf's.
- d. A Snow Day is planned for February 19th 2006. The site is still undecided, most likely area is the meadow behind the Graves. In the past this event worked best when centralized in one area. The PPOA BBQ will be onsite with warm lunch and hot chocolate, also a bonfire was proposed. Rick Mitchell will demonstrate cross country skiing, John K will be in charge of snowmobiles, Carol M will do the snow shoe portion of the day. A flyer will go out in January to remind everyone.
- e. The hike and star gazing event will be broken into different days. A Sunday hike may promote more participation, as well as meeting at the lodge for breakfast before the hike.

Membership;

Fire Safety:

- 4. A light fire engine will be stationed in Camp Nelson. It was obtained from Exeter, and going out for refurbishment and outfitting. The fire department will outlay the cost of \$5-10,000.
- 5. Testing of the fire hydrants will go ahead in the spring now that the equipment has been mastered.
- 6. A plan to start a fund raiser to purchase a light engine for Ponderosa will begin possibly next year. The estimated cost is \$15,000. This information will be passed along in the newsletter. The contact will be Margaret. A box for donations will be devised (Sharyn), as well as a 'thermometer' to display the progress of the fund raiser (John).

Newsletter:

- 1. Margaret discussed and presented the next newsletter.
- 2. An informational pamplet has been developed to go out to all new property owners.

Roads and Signs:

- 1. All signs have been reflective adapted, the sign at Snowflake and Crest is missing.
