John would like to investigate further, bring literature back, and to evaluate for possible integration into our use.
- C. Volunteer Fire Association will be purchasing an AED for all mountain communities. We will be receiving a second unit to post outside.
- D. The discussion of adding oxygen to our existing medical care kit was introduced, as a large majority of calls are cardiac in origin. John will look into getting 02 for our fire truck.

A. Bill B volunteered to participate in the Fire Safe Council. One of the projects will be working with them on the wood chipper program.
