# Ponderosa Property Owner's Association Monday, May 29, 2017 Approved Meeting Minutes

The meeting was called to order at 9.00 am by Yves DeClerck, acting for Kit Korf, president

- I. Minutes of the previous meeting: the minutes of the previous meeting were not available There was no meeting on Nov. 27, 2016 and Feb. 20, 2017
- II. Treasurer's Report: Gail Lack has informed us that on 4/21/17, there was a \$26,834.09 balance. On 10/2/16 Dave Briggs was paid \$350 for work on the mail house. She also informed the PPOA that she was leaving Ponderosa and will be leaving her position as treasurer. PPOA members were informed that Yves DeClerck has offered to fill this position if approved by Board members.

#### III. Old Business:

- a) Review of PPOA Snow Day: Yves DeClerck reported an overall low attendance probably because of the level of snow. Belgian waffles were served as breakfast at the lodge (for fee) and hamburgers were served at noon also at the lodge (subsidized by PPOA for a total cost of \$49).
- b) Update on Summit Siren: There was no update
- c. <u>Update on USDF burning of piles:</u> USDF is actively burning along highway 190 south of the lodge. Edison is also working near camp nelson. Edison may contact owners about trees that are marked for removal. It is anticipated that the removal of the many dead trees will take months or even years. An update should be included in the June newsletter. We will encourage home owners to take action to remove dead trees from their property either by working with Edison in case they are close to a power line, or by having them cut. It was suggested to consider giving owner a small financial incentive to remove the trees. In the absence of a definite treasurer report, no action was taking on this proposal. It will be re-discussed at the July meeting
- d. Status of PPOA Board by-laws There was no report on the absence of Rich Thomas
- e. <u>Update on the plaque for the PCSD building and the new entrance sign;</u> Tom Griesbach / Bill Dolmovic: Bill reported that he still needs to finalize the project. He emphasized its importance and promised to have a proposal for the July meeting. Yves proposed to

gently remind him and he agreed. It was also discussed that the building of the entrance sign will require the help of volunteers from the PPOA.

- g. <u>Staining the mail house</u>: Barbara Arnold indicated that the project will be completed by our next meeting.
- h. <u>Status of memorial for Barbara Dolmovic</u>: No report was provided in the absence of Richard Thomas. Yves will contact Richard to find out. It was agreed that this project is of high priority and needs to be completed soon.
- Status of carving into the dead tree next to the PCSD building: This item was not discussed
