#### FIRE NEAR PONDEROSA BURNS 21 ACRES



On July 8, 2017 at 1:13pm a fire was reported on the Needle Rock Rd near Ponderosa. The Fire Brigade met with the U.S. Forest Service at the scene of the fire, just past 1:30 pm. We were asked to transfer our 240 gallons of water in our Fire truck into one of their engines that was engaging the fire. The fire soon crossed the road and began to move toward the Ponderosa. Once our truck water transfer was complete, we were asked to stand down and leave the scene of the fire.

We hooked up a hose to the hydrant on Carter and parked the fire truck on Meadow Ct., as the fire began to approach the subdivision. Two helos began dropping water directly on the fire, while the fixed wing aircraft also began to drop fire retardant in front of the fire. The winds began to shift and the fire moved around Kramer Meadow. We then shifted the fire truck over to the end of Marilyn in order to keep our eye on the fire and follow its progress.

With the Forest Service ordering full suppression of the fire, to protect the Ponderosa community, the fire was reduced and finally came under control. With the air support and direct attack by firefighters the blaze was extinguished after burning approximately 21 acres. Fire teams continued to patrol and monitor the burn area for a week to ensure no flare-ups occurred.



Although the fire's point of origin was within a prescribed burn area, the cause of the fire is under investigation. While the Ponderosa was poised for evacuation, it was not necessary, due to the commitment of assets and response by the County

and Forest Service. They sent 8 engines, 6 hand crews, 2 helos and fix-winged aircraft.

A shout out goes to our neighbors from Camp Nelson, Brian and Jan Swanson, who brought up a trailer to assist in evacuation, had it been necessary. It is a breath of fresh air to have good neighbors that are so thoughtful and considerate during an emergency. It's one of the many factors that make the mountain a great place to live!



He had to leave them to go get some help on foot. Carl and Paulette passing by realized how uncomfortable Rachelle was on the roadside in the cold. They did not hesitate and stayed with her until Fabrice's return making Rachelle feel protected and much more safe.

On another occasion, we were in Ponderosa with our pregnant daughter in law whom experienced severe headaches. We wanted to check her blood pressure, but did not have the equipment. Carl right away went to get his tensionmeter and let us use it for as long as we wanted.

#### If you have not done so yet, join the PPOA now!

The specific and primary purpose of the Ponderosa Property Owner Association (PPOA) is the promotion of the welfare and enjoyment of the property owners in Ponderosa and in adjacent areas. Among the many services provided by the PPOA are:

<u>Communication among owners</u>; The PPOA maintains an accurate list of PPOA members and shares with them important information through its newsletter published 5 times a year. This coming year the PPOA will develop its own website where updated information of weather, fire, road conditions and many other aspects of our community will be posted.

<u>Working with other Ponderosa groups</u>: The PPOA works with the PCSD (Ponderosa Community Service District) and helps to maintain and repair the water system.

<u>Social events:</u> The PPOA organizes several social events each year for the community. These are opportunities for owners to meet each other, make new friends and share common interests.

Mailboxes: The PPOA maintains the mailbox building that allows owners to have mail delivered directly to Ponderosa.

Fire Brigade: Most importantly, the PPOA maintains and supports a fire brigade. This all-volunteer fire brigade known as the "Ponderosa Fire Brigade" was established in 2007 for the purpose of fire suppression, rescue, and emergency medical aid within the community and for all its benefit and safety. The Brigade is led by a Fire Chief (Dana Stewart) who promulgates policies that define duties and coverage, conducts training and maintains the necessary equipment for the best operation of the Brigade. The brigade maintains a fire truck that provides first intervention in case of fire in the area. The recent Needle Rock Road fire south of Holby Meadow on July 8 is a good example of how the fire brigade efficiently contributed to a rapid intervention by the Fire and Forest Departments that avoided a major fire in our community (see article from Dana Stewart in this issue). With an unprecedented number of dead trees in the community, we are facing for the many years to come, one of the highest levels of fire hazard in our community. Support to our fire brigade is a top priority of the PPOA.

<u>Maintenance of public space:</u> The PPOA maintains street signs and is presently working at creating a site in the honor of those who contributed to the community.

All these benefits are provided for a minimal annual fee of \$30 for homeowners and \$15 for landowners (due September 1, 2017 for 2017-2018). ### The 100<sup>th</sup> Cattle Drive For The Shannon Cattle Ranch

For the love of family, land, history, heritage and tradition

The Shannon Cattle ranch just celebrated their one hundredth bi-annual five day cattle drive. Not only is this the longest cattle drive in all of California, but it is also one of the oldest running cattle drives in California. The Shannon Ranch is based in between Terra Bella and Porterville, California. Every summer in the first week of June the Shannon family pushes their cattle up from their ranch, through California Hot Springs, up the western divide, passing Ponderosa and finally settling in Grey Meadow in the Golden Trout Wilderness.

Reuben and his brother George Shannon first started their ranch in 1917 with the help of Reuben's wife Ione. Around the 1960's Reuben and Ione's son, Jack Shannon, took over the ranch. Jack, and his wife Sandra, kept the family tradition alive until the day he died. Around 2012 Jack and Sandra's sons, Bill and John Shannon took the reins on the ranch. To this day they run a full crew made up of mostly family. John is married to Carla and they have two twins sons, Blake and Jake, and a daughter Tabitha. Bill is married to Sherry and they have two daughters, Summer and Sarah. All of which work together on the Shannon Ranch. They also have three ranch hands, James Ward, Dan Shew, and Chuck Sandborg; who are all "just as close as family," says Carla Shannon.


The Shannon's believe in saving the land. Their cattle graze in the meadows along their drive which provides a fire safe forest. It also helps reduce the unnecessary vegetation within the meadows keeping these historical meadows the same as they were a hundred years ago. "It's amazing to see a meadow that has been grazed by cattle for years...The cattle help the environment," says Carla Shannon. The Shannon Cattle Ranch isn't like any other cattle ranch. They are not only ambitious, hard working people that love what they do, but they also stand for something. They stand for preservation of land, history, heritage, and tradition. They have preserved the test of time and have made monumental strides in keeping our forests and home safe and healthy.

If you missed this spring's cattle drive, on an early morning in the middle of September the ranchers will drive their cattle back home. I am sure that with their endurance the Shannon Ranch will surpass us all in continuing their way of life for the next one hundred years.


