- All preparation must be done at the cook-off.
- Each participant will provide a list of ingredients before competition begins.
- 4. No pre-mixes: all ingredients should be in original containers.
 5. All non-vegetarian chili reserved for judges must be prepared without beans or pasta. Canned or pre-cooked beans and pasta may be added to the remaining chili for public tasting.
- If meat is used, it may be ground or chopped prior to the competition. Meat must be from government-inspected sources and wild game must be approved by the judges.
- 7. Entries may include groups, organizations, or individuals.
- 8. Only one entry per individual/organization/group.
- Each contestant must prepare a minimum of four quarts of chili at the event.

Tree Removal Grant Update

The Tulare County Resource Conservation District has secured additional funding for fuel reduction for the Ponderosa community. The Ponderosa Phase II Community Wildfire Prevention Grant has been awarded in the amount of \$531,552.00. This is in addition to last year's California Climate Investments Fire Prevention Grant for \$383,040.00.

The money will be used to fall, remove, and clean up dead, dying, and diseased trees, and to thin overcrowded stands of small trees. The intent is to create a more open, park-like forest. The result will be a much more fire safe community and a much healthier forest that is more resilient to not only fire, but to bark beetles and other forest pests.

This will be a purely voluntary project and will be done at no cost to landowners. Some landowners will want to leave more standing trees than others, and that's okay. Your input will be welcomed. But it will be important to get participation from absentee landowners to make this project successful. A checkerboard pattern of treated and untreated lots is not nearly as effective in regards to fire resistance and forest health. So if you have an empty lot near yours that needs work please help us get their attention.

Work is scheduled to begin in May. Removal of the large dead trees will require heavy equipment so this work will be delayed until at least this summer due to the moist soil conditions. Both projects need to be completed in 2021.

Jordan Slate Earthwork has been contracted to do the thinning. Thinned trees will be chipped and the chips spread onsite or removed. A Licensed Timber Operator (logger) will be hired at the appropriate time to do the large scale tree removal. Registered Professional Forester Jeff Gletne will be the Project Manager.

BURNING PERMIT AND PROPERTY CLEARANCE

With another fire season coming, it is time again to clear around your property. The PPOA Board reminds all property owners with and without a structure on their property to make sure their property is clear of dead wood and needles in accordance to the recommendations included in this Newsletter. Burning permit can be obtained at the Camp Nelson Fire Station and are valid until June 15, 2019.

Ashes: method of disposing your ashes. Place hot ashes from your stove / fireplace in a covered metal container. Leave in container until cold to the touch.

Burning Piles: Method of burning your yard debris.

Always call the Tulare County burn number to insure it is a legal burn day.

Always have a shovel, hose or fire extinguisher on hand. NEVER burn on windy days.

Chimney Fires: Method to extinguish an active chimney fire:

Throw a cup of water on to the fire than close the door to the stove / fireplace. The steam should extinguish the fire.

Recommendation: Have your chimney cleaned often by a "Chimney sweeper".


